engines, loud music. Customer communicate with the staff in the shop through the service hatch (as the staff lock the shop door after a certain time at night).

- the staff already use the tannoy to speak to customers day and night, so this being used even more because of not being allowed in the shop will be even more of a disturbance.
 - the garage already attracts people hanging around waiting for taxi's or lingering on their way to and from town, so with the shop offering food and drink 24/7 this is just going to get worse, also increasing the risk with of property being damaged/antisocial behavior

Myself and my family live [REDACTED] the Esso Garage mentioned above, we are at [REDACTED].

The garage can be a very noisy neighbour, especially at weekends. They make no effort what so ever to keep the noise level down with customers leaving on loud car radios and shouting and generally being disruptive. This is mainly an issue in the late evening, early morning with our children often woken up by the disturbances. Often when the night clubs kick out the garage becomes a destination which can be the cause of anti social behaviour.

Anything which adds to this situation would make the situation considerably worse and risks the area becoming a hang out, and with no police available these days to move people on, a garage forecourt could become a very dangerous place too.

I would like this application to be rejected as more noise than is current would be far and above that which one should expect living in such a location.
